TERMS OF USE AND STORAGE OF THE PRODUCT

- The product storage area must be chosen so that it cannot be exposed to water, steam jets, or corrosive acids.
- Protect from heat sources, direct sunlight, and atmospheric agents.
- Operating temperature range from 5 °C to + 30 °C.
- Storage temperature range from 0 °C to + 45 °C.
- The product storage area must be chosen so that children cannot reach it.
- The device is intended for indoor and outdoor use in accordance with the above instructions.

MAINTENANCE

Safety

Personal protective equipment (PPE) must be used during special maintenance operations on the product. For details, refer to the section '**Residual Risks**'.



Special maintenance operations must be performed by personnel who have read the manual beforehand. When performing these operations, strictly follow the instructions provided in this documentation.

For any maintenance work, in addition to the instructions in this manual, the general safety standards and workplace safety standards in force at the location where such operations are carried out must be observed.

Routine maintenance

To keep drains clean, it is recommended that you fill the sink completely with hot water at least once a month and then drain it so that the water pressure can keep the drain clean.

Only in cases of severe blockages may it be necessary to use a chemical drain cleaner. If this is still not sufficient, mechanical intervention is possible using a plunger or a drain snake.

As a last solution, remove and clean the siphon with a flexible brush or bottle brush.

WARNING: It is strictly forbidden to use the following substances for cleaning, as they would cause irreversible damage to the product:

- aggressive/abrasive detergents
- ammonia
- bleach.

Special maintenance

Many special maintenance operations are required in the event of unforeseeable accidents or inappropriate use of the product in question.
